Data Base Administration (DBA) supports data base administration [HKB] in a multiple Data Base Management System (DBMS) environment and the administration of data dictionaries [HKC]. It includes all software used in the database, maintenance, and operation of multiple databases within the Total Army Personnel Data Base - Reserve (TAPDB-R) CA-DATACOM environment. It is also used for management of the data dictionaries, including all of the software products used to operate or complement the passive data element dictionary. This collection also includes all activities related to enforcement and quality control of the Army Data Management Program as outlined in AR 25-9. In particular, data synchronization and data integrity activities are performed. The system includes programs that periodically examine the data for discrepancies in the quality, consistency, accuracy, reliability, or timeliness of the organization; and the system will ensure that the quality of organization data is acceptable for the intended use.

PII contained in the system includes personal, contact, emergency contact, dependent, financial, medical, disability, law enforcement, employment, education, and military record data.

(2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

All systems and environments have threats that seek to exploit and cause harm to the information. Some threats are natural, some are inherent in the system design, some can be attributed to unauthorized personnel, and some to authorized personnel who make mistakes. Four general categories of threats exist: human-intentional, human-unintentional, structural, and natural. The system is maintained in a controlled facility. Appropriate technical, personnel, physical and operational safeguards are in place for the access, collection, use and protection of information. Due to the level of safeguarding, we believe the risk to individuals' privacy to be minimal.

Science Applications International Corporation contractual language acknowledges the sensitivity of PII and describes the importance of protecting and maintaining the confidentiality and security of a Soldier's PII. The contractual language keys on training as a fundamental element in creating awareness and understanding of PII and why it is important to control and safeguard. The language also stresses securing PII material and equipment housing PII at the end of a work day. Contractual language directs and requires each SAIC employee in support of the database to have a valid Secret clearance prior to working on the program. The contract specifically states that contractor personnel will adhere to the Privacy Act, Title 5 of U.S. Code Section 522a, and all applicable agency rules and regulations.
