- (1) Describe the purpose of this DoD information system or electronic collection and briefly describe the types of personal information about individuals collected in the system.

Laserfiche is an application that is being utilized by the AMCOM G6 to assist with the implementation of Records Management for all Official Digital Documents. Laserfiche allows for the quick search and retrieval of documents by permitting the user to not only browse through a filing structure that is convenient for the user, but also giving the user the ability to search the entire repository for documents that contain a key word or phrase. All media and systems selected to store and manage electronic records throughout their life cycle must meet the requirements of Department of Defense (DOD) 5015.2-STD and the Army Records Program (AR 25-400-2, DA PAM 25-403). Laserfiche is DoD 5015.2-STD compliant and meets the requirements of the Army Records Program which allows it to be used as the primary vehicle for the storage and administration of Records Management for digital documents. Laserfiche gives the Records Manager the ability to quickly determine which documents are scheduled for a Records Management event and to easily search for these documents.

- (2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

The risk associated with the PII being collected is that individuals who participate could have their personal information released. Our assessment determines that due to the nature of the PII collected there is a reduced risk of harm to individuals. This risk is further mitigated through the use of firewalls, antivirus software, CAC access, encryption and physical security measures in place related to the facility.

Due to the level of safeguarding, we believe the risk to individuals' privacy to be minimal. There is a low risk that information may be accessed by unauthorized users through unauthorized access or network breaches. Laserfiche will be protected by the use of Secure Sockets Layer (SSL) protocol; firewalls; antivirus software; logon name/passwords to control access.

The application then generates a plain text version of the digital file that can be scanned for keywords or phrases. The specific file or folder is only assessable to users who have been granted view access rights to the named file or folder. No additional information will be collected for this application. Only existing documents will be entered into the system.

Routine Use(s): The DoD 'Blanket Routine Uses' set forth at the beginning of the Army's compilation of systems of records notices also apply to this system.
