The Virtual Contracting Enterprise (VCE) provides a standardized suite of Electronic and Web based tools utilized by Army Contracting Command's (ACC) employees and customers in acquiring goods and services for the Army. Only names, citizenship, clearance information, and job functions will be used to authenticate, authorize, and add users to processes entering into the Virtual Contracting Enterprise E-tool and Application tool suite. No information is released outside of the parent DoD component which is Army Contracting Command.

(2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

The risks are limited due to the limited nature of data collected. Data transmitted from system to system is encrypted and data at rest is also encrypted. Access to this data is limited to authorized personnel.

The following clauses are written in the contract to ensure safeguards are in place to

protect sensitive information:  
6.1.1 Access to Government Data - The Contractor shall have access to procurement sensitive information to include contractors price and cost data, proprietary information related to Government contracting and source selections. As such, the contractor shall sign the Non Disclosure Agreement (NDA) to ensure this or any related information is not improperly disclosed. In addition each onsite employee and/or those employees requiring access to ACC VCE applications shall sign the NDA.  
6.1.3 Access to Sensitive Information - The contractor must abide by all personnel security requirements per AR 25-2, Para. 4-10, 4-14 and 4-15. Requirements vary depending on contractor role.  
6.1.3.3 Roles/Privileges - The Contractor shall ensure that role/privileges assigned to Contractor employees on the Government platform and applications are limited to the role/privileges essential to that individuals performance of his/her assignment.
